

You are requested to supply the material as per indent enclosed on following Terms and condition in addition to those as laid down in Rate Contract. 'x' PUR/20/05/1694-92 dated 30-12-08 & PUR/20/05/1703-11 dt. 30-12-08

1. The Chemicals/Glassware's /Plasticwares / FilterPapers shall be supplied F.O.R SLIET Camps, Longowal, Distt. Sangrur (Pb.) free of additional charges.
2. Discount: The prices as per manufacturer's price list as shown against each item. A discount of 5 % shall be allowed on each item.

3. Payment: 100% payment shall be made on receipt of complete supply, inspection and acceptance of material in good condition within 30 days. For processing payment, bill in duplicate should be submitted at the time of delivery.
4. Sale Tax/VAT is payable separately at the prevailing rates without form D/C. However, form of certificate for being an Educational Institute can be issued if ST/VAT rebate is permissible.
5. Delivery: You will strictly supply full quantity of Chemicals/Glasswares /Plastic Wares/Filter Papers within 45 days or from the date of issue of this supply order. Part supply is prohibited, however, if material is not readily available and items are in large number, part dispatch upto four lots will be allowed but that too within 45 days. The time and the date of delivery of stores

stipulated shall be deemed to be the essence of the contract and delivery must be completed not later than the date specified. The stores supplied/delivered after the date of delivery are liable to be rejected and you shall be equally responsible for all consequences of such rejection/refusal. Penalty @2% per Week will be charged from the bill after expiry of delivery date. In the event of non-adherence to the stipulated delivery period for any specific reason on your part, you may apply in writing for extension thereof but the purchaser will be at his liberty to accept or reject your request for such extension and this action on the purchaser part will be without any financial repercussion to the contract price. Institute may invoke liquidated damages as per rules.

6. The goods shall be brand new. The goods shall be inspected on delivery. The supplied goods should be exactly according to the specifications given in the supply order. Any article found defective will not be accepted. Such article(s) shall be removed from the institute by you at your own arrangement at your risk/cost.
7. Only those items which are according to specifications and are received in perfect good condition and approved by the office will be paid for. Rejection, if any shall be replaced free of cost by you within reasonable time.
8. Director's right: Director, SLIET reserves the right to terminate the contract & forfeit security without assigning any reason whatsoever, in case of any dispute, the decision of Director, SLIET shall be final & binding on both the parties. Otherwise all the disputes will be settled within the jurisdiction of Headquarter of Director, SLIET.
