Result of Candidates recommended for admission to Ph.D. Programme, on the basis of Merit based upon (Entrance test SET-VIII held on June 26, .2011 and subsequent interview held on July 16, 2011 & December 30, 2011 for the session 2011-12).

The Criteria of admission of students is recommended as follows:

- I) The panel of students, recommended for Ph.D admissions is valid for Even semester of Academic Session 2011-2012, only subject to consent/request from concerned department
- II) English and Management departments (namely EDP) shall be regarded as one department.
- III) During Even Semester (starting w.e.f.4th January, 2012) 02 (two) candidates in order of merit shall be admitted under full time (with fellowship) category in the English stream & 03 (three) candidates in order of merit shall be admitted under full time (with fellowship) in the Management stream, both in the department of EDP, subject to consent/request from concerned department. Selected candidates for institute fellowship may get their offer letters from the department, concerned.
- IV) Number of candidates to be admitted under the full time (without fellowship) and Part-time categories shall be decided by the department, subject to availability of supervisor.
- V) The following documents are required at the time of admission under part time and Full-time (sponsored by Institutes) candidates:
 - * NOC from the employer, where the candidate is working
 - * Consent of supervisor before enrolment in the prescribed format
- VI) Procedure for admission during the Even Semester:
 1. Date of Enrolment: upto 24.01.2012
 2. All the eligible candidates, as detailed below for Full time with Institute Fellowship & part time are required to reach the concerned department on the date of enrolment for enrolment.
 3. Candidates are required to deposit the fee as detailed in the Information Brochure for SET-VIII-2011 on the date of Enrolment

iii) Fellowship in the English stream of EDP department is awarded in view of Rule 2.4.1 (typed below) of SLIET Entrance Test:

“2.4 Principles of Reservation Applicable to all admissions)

2.4.1 All admissions will be made on merit determined for admission. In case of tie among two or more candidates, candidate elder in age as per the relevant entry in the matriculation certificate shall be placed higher in merit. Again, if there is tie in age (date of birth), candidate having higher marks in qualifying examination shall be placed higher in merit”
